For over sixty years, Burritt on the Mountain has meant so much to so many. We would like to



EDUCATION

In addition, our docents in the mansion and interpreters in the Historic Park are trained to provide factual information with the ability to put your experience into context with modern life. ART

Our varied classes preserve these skills by passing them along to new would-be artists and we have more wonderful plans for the Burritt Folk School on the horizon! The line-ups for City Lights and Stars reflect a variety of genres and two of the wings in the Burritt Mansion are used for rotating exhibits. The Arts are thriving at Burritt.

PRESERVATION

Preservation means a variety of things here. Whether it is the preservation of a way of life or the preservation of a home that could tell a thousand stories, we honor the past and want to preserve it for future generations. Dr. Burritt's mansion, six historic homes, an Old Country Church, a barn and outbuildings, each one as important to the fabric of Burritt on the Mountain as the next.





BEQUEST

You can provide now for a future gift to Burritt on the Mountain by including a bequest provision in your will or revocable trust. Burritt receives the gift, and applies it to the purpose(s) you specify.

Benefits

- Your assets remain in your control during your lifetime.
- You can modify your bequest if your circumstances change.
- You can direct your bequest to a particular purpose (be sure to check with Burritt to make sure your gift can be used as intended).
- There is no upper limit on the estate tax deductions that can be taken for charitable bequests.
- You know that your gift will benefit Burritt tomorrow just as you intend it to today.

CHARITABLE GIFT ANNUITIES

You transfer cash or securities to Burritt on the Mountain. Burritt pays you, or up to two annuitants you name, a lifetime annuity. The principal passes to Burritt when the contract ends.

Benefits

- You receive an immediate income tax deduction for a portion of your gift.
- Your lifetime annuity is backed by a reserve and the full assets of Burritt on the Mountain.
- Your annuity payments are treated as part ordinary income, part capital gains income (15%), and part tax-free income.
- You have the satisfaction of making a significant gift that benefits you now and Burritt later.

General Burritt is a piece of my heart as I've watched it gradually morph into one of Huntsville's most beautiful venues. It's a place where dreams have come true with the Baron Bluff and now The View. I've spent many hours working with wonderfully committed volunteers.

LIFE INSURANCE

You can provide now for a future gift to Burritt on the Mountain by naming us owner and beneficiary of a policy insuring your life. You make annual gifts to Burritt in the amount of our premium payments. When the policy matures the proceeds are paid to Burritt on the Mountain, and we apply them to the program you have designated.

Benefits

- You can make a significant gift from income instead of capital.
- Your gifts offsetting our premium payments are fully deductible.
- You build our future financial strength.

RETIREMENT ASSETS

You name Burritt on the Mountain as the beneficiary of your IRA, 401(k) or other qualified plan. After your lifetime, the residue of your plan passes to the Burritt.

Benefits

- You can escape both income AND estate taxes levied on the residue left in your retirement account by leaving it to Burritt on the Mountain
- Give the most-taxed asset in your estate to Burritt, and leave more favorably taxed property to your heirs.
- You can continue to take withdrawals during your lifetime.
- You can change the beneficiary if your circumstances change.
